## **5. Storage duration**

The personal data mentioned above will be stored for the period required for the purposes stated above. If you withdraw your consent, the data will be deleted.

## **6. Withdrawal of consent**

At any time and with future effect, you may withdraw your consent to the processing of photos, video or audio recordings as well as the corresponding data. A withdrawal of consent does not affect the lawfulness of processing up to that point since consent had been provided before its withdrawal.

## **7. Your rights**

You have the right to obtain information about the personal data processed and stored by the Dr. August und Annelies Karst Stiftung and its partner institutions, especially the University of Konstanz (Art. 15 GDPR), the right to have data corrected or deleted (Art. 16 and 17 GDPR), the right to limit the processing of data (Art. 18 GDPR) and the right to revoke your consent (Art. 7 para. 3 GDPR).

You also have the right to file a complaint with the regulating authority.
